President's News

Dear ISHPES members,

the year 2011 can be regarded as a highly successful year for ISHPES. In March, quite a number of members visited the congress "Winter Sport and Outdoor Life" in Bø, Telemark, organized by Gerd von der Lippe and Halvor Kleppen and supported by ISHPES.



In July the ISHPES Congress 2011, titled "From Gymnastics to Sports — Relations, Interactions, Contradictions in the Past and the Present: A Congress on the Occasion of the Founding of the German Turner Movement in 1811", was hosted by the Deutsche Tuner Bund and under my leadership in Frankfurt, celebrating the anniversary year of "200 years of Turnen in Germany". About 100 people from 20 countries participated in the congress.

I want to take this opportunity to once more congratulate Bieke Giles, who won the Gigliola Gori Junior Scholar Award with the topic "The Only Race Aviatrix in the World: A Tribute to Bessie Coleman (1892-1926)". So far, there have never been so many submissions for this award. Wray Vamplew was honored for his sport historical contributions. Furthermore, Heribert Aigner, Gigliola Gori and Tokuro Yamamoto were appointed ISHPES honorary members for their longtime support and merit concerning the interests of ISHPES.

For the first time, we organized a workshop particularly for young scholars at our congress which attracted a large number of participants. Valuable hints concerning academic congresses, publications and networking were shared. The social gathering helped to get in touch with other young scholars and academics and to create a personal network. This get-together will be an important component of our congresses in the future. Apart from that, the workshop participants agreed that Sandra Heck will be in charge of the young scholars for another year. One of the main objectives of her work is to improve the networking among the graduate students and junior scholars as well as the interaction with ISHPES as an institution and the exchange with experienced sport historians. As a first step, an e-mail list and an overview with all junior scholars and their research topics was created. Not only our young scholars, but also all other interested persons, members and non-members are invited to join our ISHPES facebook group. This shall help to spread our ideas and activities and to enlarge the international circle of ISHPES supporter. You can find the group online:

A well-attended general assembly also took place as part of the congress. It was announced that the next ISHPES Congress will be help in Rio de Janeiro, Brazil. Sebastiao

Votre is the person in charge of the upcoming congress with the title "Sport and Physical Education around the Globe – Past, Present and Future". You can find more information about the congress in this bulletin. In 2013, the ISHPES Congress will be held in Taiwan. South America and Asia are important continents for us since we have a large number of members coming from these regions. So far, there have been none or only a few ISHPES congresses in these parts of the world. As an international association we also have to be present in these areas in order to activate and deepen the sport historical discourse.

ISHPES also has given patronage to scientific meetings. This is the case at the "1st Conference on the History of Women and Sport: From Past to Future" in Doha, Qatar in January 2012. And we will host two sessions at the ICSEMIS Congress in Glasgow before the Olympic Games 2012: "Historical Aspects of Doping and Anti Doping: The Failure of Policy and Morality" und "London: Global City and Olympic Legacies'".

To stress the internationality of our association again: Currently we are having more than 150 members from over 27 countries. Due to the international membership, the internet is getting more and more important as a means of communication. Our webmaster, Heather Dichter, has developed an amazing homepage over the last two years, which is updated regularly. A challenge we want to master in the future is the possibility to elect the Chair and the Council online. We still need to work out the basics for that.

I want to mention another novelty: From now on, we will not only be working with STADION but also with the International Journal for Sport History (IJSH) more closely. The IJSH is planning on publishing some of our articles from our congresses. I want to thank both journals for their support.

Once more, I want to thank Gigliola Gori and Gerd von der Lippe, who both again supported ISHPES with generous donations. Only because of that it is possible to hand over the Gigliola Gori Junior Award and to take over some of the travel costs of our young scholars, through money provided by the Gerd von der Lippe Traveling Fund. For everyone who wants to make a contribution to that is more than welcome to make a cross under the category Join/Donate to ISHPES and to transfer a certain amount of money. One of our central goals is the promotion of our young scholars.

I wish you all the best for the year 2012 and I'm looking forward to seeing you all in Rio.

Chers membres de l'ISHPES,

L'année 2011 peut être vue comme très positive pour l'ISHPES. En mars, un nombre relativement important de membres se sont rendus au congrès "Winter Sport and Outdoor Life" à Bø, Telemark, organisé par Gerd von der Lippe et Halvor Kleppen avec le support de l'ISHPES.

Le congrès 2011 de l'ISHPES, sous le titre « De la gymnastique aux sports — relations, interactions, contradictions, dans le passé et le présent : un congrès à l'occasion de la fondation du mouvement allemand du Turnen en 1811 », a été accueilli par la Fédération de Turnen et sous ma présidence à Frankfurt, en célébrant le 200ème anniversaire du Turnen en Allemagne. Environ 100 personnes de 20 pays ont participé à ce congrès.

Je veux saisir cette opportunité pour féliciter une nouvelle fois Bieke Giles, qui a gagné le Gigliola Gori Junior Scholar Award avec son sujet sur « The Only Race Aviatrix in the World: A Tribute to Bessie Coleman (1892-1926) ». Du reste, il n'y a jamais eu autant de propositions pour ce prix. Wray Vamplew a été honoré pour sa contribution à l'histoire du sport. De plus, Heribert Aigner, Gigliola Gori et Tokuro Yamamoto ont été proposé comme membres honoraires de l'ISHPES pour leur support durable et leurs mérites au regard des intérêts de l'ISHPES.

Pour la première fois, nous avons organisé un atelier spécifique pour les jeunes chercheurs, qui a attiré un grand nombre de participants. Des conseils utiles sur les congrès, les publications et les réseaux ont été échangés. Cette mise en relation a permis d'entrer en contact avec d'autres jeunes chercheurs et des universitaires, et de créer un réseau. Ceci sera une composante importante de nos congrès dans le futur. Par ailleurs, les participants à l'atelier ont accepté que Sandra Heck soit en charge des jeunes chercheurs pour une nouvelle année.

L'un des principaux objectifs de son travail est d'améliorer la mise en réseau des jeunes chercheurs ainsi que les interactions avec l'ISHPES en tant qu'institution et les échanges avec des historiens du sport expérimentés. Une première étape a consisté à créer une liste d'adresses électroniques avec tous les jeunes chercheurs et leurs sujets de recherche. Non seulement les jeunes chercheurs, mais aussi tous les chercheurs en sciences du sport intéressés, les membres comme les non-membres, les jeunes et les moins jeunes sont invités à rejoindre notre groupe ISHPES sur facebook. Cela devrait favoriser la diffusion de nos idées et de nos activités, et élargir le cercle international des supporters de l'ISHPES. Vous pouvez trouver ce groupe en ligne sur:

Une réunion très suivie des membres s'est aussi tenue pendant le congrès. Il y a été annoncé que le prochain congrès de l'ISHPES se tiendrait à Rio de Janeiro, au Brésil. Sebastiao Votre est la personne en charge de ce prochain congrès dont le titre est : "Sport et éducation physique autour du globe — passé, présent et futur ». Vous pouvez trouver davantage d'informations sur le

congrès dans ce bulletin. En 2013, le congrès de l'ISHPES aura lieu à Taiwan. L'Amérique du Sud et l'Asie sont d'importants continents pour nous dans la mesure où nous avons un grand nombre de membres en provenance de ces régions. Du reste, peu ou pas de congrès de l'ISHPES se sont déroulés dans ces parties du monde. En tant qu'association internationale, nous avons à être présents dans ces régions afin d'activer et renforcer l'histoire du sport.

L'ISHPES fournit aussi des patronages à des réunions scientifiques. C'est le cas pour la « 1ère conférence sur l'histoire des femmes et du sport : du passé au futur », à Doha, au Qatar, en janvier 2012. Et nous accueillerons deux sessions au congrès ICSEMIS de Glasgow, avant les Jeux olympiques 2012 : « Aspects historiques du dopage et de la lutte contre le dopage : l'échec de la politique et de la moralité » et « Londres, cité mondiale et héritage olympique ».

La dimension internationale de notre association est aussi soulignée par nos plus que 150 membres provenant de plus que 27 pays. Pour cette raison, l'Internet devient de plus en plus important comme moyen de communication. Notre webmaster, Heather Dichter, a développé un site étonnant ces deux dernières années, qui est mis à jour régulièrement. Un défi que nous voulons relever dans le futur est la possibilité d'élire le Président et le Conseil en ligne. Nous ne sommes cependant pas encore tout à fait prêts pour cela.

das Jahr 2011 kann als ein überaus erfolgreiches Jahr für ISHPES bezeichnet werden. Im März besuchten viele Mitglieder den von Gerd von der Lippe und Halvor Kleppen organisierten Kongress "Winter Sport and Outdoor Life" in Bø, Telemark, den ISHPES mit einer Patronage unterstützt hat.

Der IHSPES-Kongress 2011 wurde anlässlich des Jubiläums "200 Jahre Turnen in Deutschland" in Frankfurt unter meiner Leitung vom Deutschen Turner-Bund (DTB) zum Thema "Vom Turnen zum Sport – Beziehungen, Interaktionen, Gegensätze in der Vergangenheit und in der Gegenwart: ein Kongress zur 200jährigen Gründung der Deutschen Turnbewegung" ausgerichtet. Rund 100 Personen aus 20 Ländern nahmen daran im Juli 2011 teil.

Gratulieren möchte ich nochmals Bieke Gils, die mit dem Thema "The Only Race Aviatrix in theWorld: A Tribute to Bessie Coleman (1892-1926)", den *Gigliola Gori Junior Scholar Award* gewonnen hat. Es gab noch nie so viele Bewerber für diesen Award wie in diesem Jahr. Wray Vamplew, wurde der *ISHPES Award* für seine sporthistorischen Arbeiten überreicht. Zudem haben wir Heribert Aigner, Gigliola Gori und Tokuro Yamamoto für ihre langjährigen Verdienste um die Belange von ISHPES zu Ehrenmitgliedern ernannt.

Zum ersten Mal haben wir bei einem Kongress einen Arbeitskreis für den Wissenschaftlichen Nachwuchs organisiert, der sehr gut besucht war. Hier wurden Tipps für wissenschaftliche Tagungen, Veröffentlichungen und Netzwerkbildung weitergegeben. Zudem wurde ein gemütliches Zusammensein zum besseren Kennenlernen durchgeführt. Diese Treffen sollen zukünftig ein fester Bestandteil unserer Kongresse sein. In Frankfurt wurde zudem im Kreis der Junior Scholars entschieden, dass Sandra Heck ein weiteres Jahr für den Nachwuchs zuständig sein wird.

Ein Hauptziel ihrer Arbeit besteht in der besseren Vernetzung der Nachwuchswissenschaftler/Innen untereinander sowie mit ISHPES als Institution und im Austausch mit erfahrenen Sporthistorikern. Als erste Schritte in diese Richtung sind im Anschluss an die Konferenz ein Email-Verteiler und eine Übersicht mit allen ISHPES-Junior-Scholars und ihren Forschungsthemen entstanden. Des Weiteren besteht Möglichkeit für alle interessierten Sportwissenschaftler/Innen, unabhängig davon, ob sie bereits ISHPES-Mitglied sind oder nicht – unserer ISHPES-Facebook-Gruppe beizutreten. Diese soll dazu beitragen, unsere Aktivitäten über unseren engen Mitgliederkreis hinaus bekannt zu machen und so möglicherweise den internationalen Kreis der ISHPES-Anhänger zu erweitern. 2012 Gigliola Gori Junior Scholar Award

ISHPES is currently accepting applications for the 2012 Junior Scholar Award. The ISHPES GIGLIOLA GORI JUNIOR SCHOLAR AWARD will be presented at the 2012 ISHPES Congress to be held in Rio de Janiero, Brazil from July 9-13, 2012

Gigliola Gori, a leading sport historian in Italy and longtime member of ISHPES, as well as one of its current Vice-Presidents, has very generously donated a 1000 euro prize for the ISHPES Junior Scholar Award. This award is intended to promote emerging scholarship among young scholars of sport history world wide through the organizational support of ISHPES and its members.

It is awarded for an unpublished essay of outstanding quality in the field of sport history. Eligible scholars must be a member of ISHPES and a registered student (undergraduate or graduate) at the time of the Congress or a junior scholar (within one year of receiving a PhD). The essay must be submitted in English and the text itself (including notes and bibliography) must not exceed 10,000 words.

The main criteria for selection will be based on originality, the scientific quality of the research and the value of the study from the perspective of international sport history.

The award winner will receive the 1000 euro prize, free registration at the Congress and a year's membership to ISHPES. His/her paper will be published in Stadion and the winner, together with any other entrant whose work is recognized by the committee for its quality, will receive a diploma that will be presented during the Congress.

The essay must be emailed to the Chair of the Awards Committee, Patricia Vertinsky, to awards@ishpes.org no later than **March 31, 2012**.



Gerd von der Lippe Junior Scholar Travelling Fund

In 2012 ISHPES will offer several grants from the GERD VON DER LIPPE JUNIOR SCHOLAR FUND to assist graduate students who present papers at the Congress.

The money will be divided among the applicants to help defray the costs of travel and accommodation at the conference. Exact amounts of the financial support will vary.

A graduate student requesting travel funds must make a request for a Gerd von der Lippe Junior Scholar Fund grant at the same time as the abstract submission. Applications should consist of a concise letter from the prospective participant requesting a grant from the Gerd von der Lippe Junior Scholar Fund, sent to Dr. Kai Reinhart, ISHPES General Secretary, at info@ishpes.org.

DEADLINE: May 31, 2012

Requirements:

- Be a current ISHPES member. (Join here)
- Include applicant's academic affiliation
- Include the name and email address of applicant's graduate program advisor

Funding requests will have no bearing on the scientific committee's decisions on panels, but funds will not be awarded unless the applicant's paper is accepted by the scientific committee in a separate decision.

All recipients must register for the ISHPES conference in advance. This financial support will be disbursed to recipients by the ISHPES General Secretary at the conference. The winner of the Gigliola Gori Junior Scholar Award is not eligible for financial support from the Gerd von der Lippe Junior Scholar Fund.



The International PhD Summer School 2011 at the University of Copenhagen

Camps Y Wilant, Natalia & Krone, Lena (University of Education, Ludwigsburg)

From August, 22 to 27, the International PhD Summer School took place at the University of Copenhagen. It was organized by Gertrud Pfister and the Faculty of Science, Department of Sport, Politics and Welfare. Thirty selected participants representing institutions from Europe, as well as North America, Iran and Taiwan chose to attend. The purpose of this annually organized event is to offer young researchers an opportunity to present their research undertakings to a selected group of international experts, to engage in critical discussions and to establish a network.

The daily programme for the event was divided into three blocks. A broad selection of interdisciplinary lectures was held by the experts every morning. Sports psychologist Anne Marie Elbe (University of Copenhagen) explained different developmental trajectories of young athletes in sports at the elite level. The own personality and the body in sport-related settings was the topic presented by Reinhard Stelter (University of Copenhagen). Gertrud Pfister & Laila Ottesen (University of Copenhagen) gave the international audience an insight into Danish society and their enthusiasm for sport. A sailing project presented by Claudia Kugelmann (University of Munich) demonstrated how new forms of experience-oriented learning were implemented. Susanna Hedenborg (University of Malmö) focused on childhood and the importance of sport. The phenomenon of how sporting events can serve as unifying element in identity formation was explained by Joseph Maguire (Loughborough University). The lecture of Ian Ritchie (Brock University) was about the use of performance enhancing methods and substances in sport. Andy Smith (University of Chester) presented individual examples of mental suffering in professional sport. Gender constructions and relations at various levels and in different sport institutions were the topic of Susanna Soler (University of Barcelona). Gerald Gems (North Central College) concluded the lecture series with a review of American immigration history and its link to (sport) specific challenges of migration.

These lectures formed the topics for the students' presentations in the afternoon. The PhD research undertakings ranged from sports history and physical educational issues to questions about the sociology of sport. Subsequent discussions with experts and the audience offered valuable suggestions for presentation improvement and endorsing literature. The official programme of the day was completed by guided workshops that addressed research methods, publication issues, and organizational processes during a research project as well as - if desired – individual supervisions with the experts.

Finally the evenings provided an opportunity to explore the insights into the Danish culture. As mentioned above, sport and physical activity plays an important role in everyday life for the Danish people. As a result of the excellent organization of the University of Copenhagen, the participants could experience the sport facilities of the International Sport and Culture Association (DGI-byen) through a guided tour. A presentation by the Danish Foundation for Culture and Sport Facilities highlighted the "Sports for All" vision and the Danish lifestyle. What better way to get to know this "lifestyle" than by riding a bike through the city? Therefore physical activity was also part of the daily programme.

The participants characterized the Summer School as an inspiring and motivating learning experience, to which all the participants contributed. Knowledge and experience were exchanged, international contacts made and valuable impetus for further work on the research projects could be captured and taken home. Due to a productive atmosphere during the day many interesting and stimulating discussions between all participants arose even during the coffee breaks.

Particularly the experts made a wonderful contribution by sharing knowledge and advice from their own academic career with the young scholars. Hopefully Gertrud Pfister, her colleagues and international sport associations like ISSA and ISHPES will continue their dedication in supporting this International PhD Summer School in the future.

1st Conference on the History of Women and Sport: From Past to Future

The Qatar Olympic & Sports Museum (QOSM) and the Qatar Women's Sport Committee (QWSC) will realize the "1st Conference on the History of Women and Sport: From Past to Future". The event took place in the Museum of Islamic Arts in Doha (Qatar) on 22th to 24th of January 2012. The aim of the conference was to discuss the historical development of Women and Sport in past, present and future from a GCC (Gulf Cooperation Council) countries' perspective. On this conference international scholars discussed women's contributions in the past and in the present to sport, their positions and the challenges women are facing. Here is a report of the conference by Svenja Mintert:

ISHPES patronaged the 1st Conference on the History of Women & Sport: from Past to Future hold in Doha, Qatar from 22 to 24 January 2012. Organized by the Qatar Olympic and Sports Museum and the Qatar Women's Sport Committee (QWSC) the event was under the auspices of Sheikha Jawaher Bint Hamad Bin Suhaim AlThani, the wife of His Highness the Heir Apparent of Qatar. The hosts welcomed a large number of international specialists and academics from Bahrain, Kuwait, Oman, Qatar, Syria, UAE, Australia and Europe to shed light on topics related to women's sports activities and the challenges they face from the Arab countries' perspective.

The well-structured conference featured proactive panel discussions (simultaneous translation has been provided in Arabic and English) between speakers and participants on the evolution of women's sports in addition to organizing workshops for like-minded representatives of the GCC women's sports association and female figures in the world of sports.



The "Past" highlighted the grassroots by setting the focus on "Women and Sport in Antiquity" and was presented by Dr. Christian Wacker, Director of the Qatar Olympic & Sports Museum. Wacker opened the agenda by verifying the early stages and barriers in women sport. The following talk by Prof. Gertrud Pfister

(University of Copenhagen) put the emphasis on women at the Olympic Games providing a powerful public platform to showcase the achievements of women athletes. Furthermore, she embarked upon a comparison of Olympic media coverage during the 2004 Olympic Games and on how the sports news media generally represent female athletes.

With the topic of "History of women's sport in different cultures" an introductory overview was provided by Dr. Marcia Neto from Qatar and opened up the discussion towards the history of women's sport in the Arab countries given by Nour El Houda from Syria. El Houda indicated that women in Syria have made good progress and development in sports. In order to maintain this progress, women would have to be armed with awareness, education and courage in facing the obstacles they meet. An introduction in practical experience about women's sport in Qatar in the last ten years was presented by Lolwa Al Marri who is the Secretary General at the Qatar Women's Sport Committee that is committed to play a positive role promoting its performance towards facing the actual challenges in view of the economic and social development that Qatar has been witnessing in the recent years. The Committee is looking forward, at present, to continuing improving its competency in a way, which would be compatible with the future Qatar National Vision 2030.

The emphasis of the "Present" has been put on themes about "Physical Education", "Examples for sport for all" as well as "Women, Sport & Leadership" and focused on the current challenges to be faced by sports organizations. Qatar Olympic Committee president Sheikh Saoud bin Abdulrahman Al Thani was present and open towards queries posed by the conference attendees. He affirmed that female athletes have been competing in international tournaments for the past three years. In addition he set the focus on the School Olympic Program, which has been established as an integral part within the Qatari society as a whole and has even become a national project. Also, by establishing a

larger number of facilities in the region young families are invited to integrate physical activity into their everyday life.

Prof. Tansin Benn (University of Birmingham) examined the global experiences, challenges and achievements of Muslim women participating in physical activities and sport. According to the recent project of Benn, Pfister, & Jawad, (Eds) "Muslim Women in Sport" (2011) presents an overview of current research into constructs of gender, the role of religion and the importance of situation. It further seeks to make important recommendations for improving access to sport for girls and women from Muslim communities. Under the aegis of the International Association of Physical Education and Sport for Girls and Women (IAPESGW) Dr. Yousra Al Sinani who is the Assistant Professor in Physical Education (Sultan Qaboos University) has covered the second agenda part of "Physical Education" by addressing findings of the study in "The Sultanate of Oman and the Position of Girls and Women in Physical Education and Sport" offering an original insight into the position of Omani girls and women in the field of physical activity in education, recreation and sport. Oman is one of the most recent countries to develop opportunities for women in physical education and sport. The study emphasizes the importance of good quality programs of physical education and sport within school curriculum time, especially for girls.

Prof. Dr. Annette Hofmann (Ludwigsburg University of Education) elaborated the sports for all possibilities for women within the German sports system. She then showed examples for women within a context of best practices. Together with Dr. Canan Koca (University of Ankara) who is currently researching on physical activity participation of women who migrated from Western countries to Turkey the main topic stated "Examples for sports for all". Koca indicated that girls and women are not represented in decision-making committees. In turn, their participation in physical activities may often not be taken into consideration.

The agenda point "Women, Sport & Leadership" has been covered by Prof. Susanna Hedenborg (Malmö University) and Dr. Anita White (University of Chichester). At the center of their talks were intentions to focus more on empowerment and to take over leadership roles for women in sports.

Concluded with an interactive panel discussion on "Women & Sport in GCC — Future Perspectives" the focus has been put on future trends and developments in sports within the Arab countries. At the final session, the Chairperson of QWSC emphasized on the ideas that have been exchanged during the 3-day event stressing that women in Qatar are on the right path for further progress and development within the country's 2030 vision. A number of recommendations emerged from the event and discussions. More can be found soon on the ISHPES homepage.



Conference on Sport, Conflict and Reconciliation

Liverpool Hope University Saturday 28 April 2012

CALL FOR PAPERS

Sport can be both a source of conflict and a means of promoting reconciliation and peace-building. This one-day conference aims to examine theoretical debate and practical approaches to the role of sport in relation to conflict and conflict resolution.

A particular interest of the conference lies in the area of the use of sport for purposes of conflict resolution, post-conflict reconstruction and rehabilitation, and peacebuilding. Prof. John Sugden, Professor of the Sociology of Sport at the Chelsea School, University of Brighton, will be giving a keynote address on this theme. In addition, the conference organisers will be aiming to organise at least one panel specifically on this theme, so we particularly welcome papers in this area.

However, we also welcome papers looking at other aspects of sport and conflict, and from any discipline, including geography, sociology, politics, economics, cultural studies, history, media studies, literature, and sports studies. Amongst the themes that could be considered are:

- Theoretical perspectives on understanding the interactions of sport with conflict and with post-conflict rehabilitation
- Case study evaluations of historical or contemporary instances of the relationship between sport and conflict/conflict resolution
- Organisational studies looking at the role of agencies such as ngo's, governing bodies, political institutions, economic actors and educational bodies in sport
- Comparative assessments of the interplay between sport and conflict in different circumstances and contexts

- Analytical studies looking at the key themes and issues of relevance in using sport as an interventionist tool for peacebuilding
- Philosophical and ethical evaluations of the roles of sport, both in engendering conflict and in promoting its resolution.
- Assessments of methodological approaches to the analysis of the role of sport in conflict and conflict resolution.

The conference is being organised by the Archbishop Desmond Tutu Centre for War and Peace Studies at Liverpool Hope University. The conference organisers are Dr Michael Holmes, Dr Liam O'Callaghan and Dr Joel Rookwood. The venue will be the Conference Centre, Liverpool Hope University, Hope Park campus, Taggart Avenue, Liverpool.

UNESCO selects Sportimonium as 'best practice'



A programme of cultivating ludodiversity: safeguarding traditional games in Flanders

During its 6th session, the Intergovernmental Committee for the Intangible Cultural Heritage, UNESCO, has decided on November 25 in Bali (Indonesia), to select the Sportimonium, proposed by Belgium, as a programme best reflecting the principles and objectives of the UNESCO Convention of 2003 for safeguarding intangible cultural heritage.

Ludodiversity refers to the wide diversity in games, sports, physical exercises, dances and acrobatics. The non-governmental organization Sportimonium, together with local communities and associations, has taken measures to safeguard the heritage of games and sports in Flanders, Belgium, including twenty-three types of traditional games, among them forms of shooting games, bowl games, throwing games and ball games. Safeguarding measures undertaken by Sportimonium include support to specialized and umbrella organizations, publications, festivals, demonstrations, exchanges of expertise, promotion activities, loan services providing people with traditional games equipment, and a Traditional Games Park. The basis for the programme is systematic documentation and research: information on traditional games and sports has been gathered worldwide and can be consulted in a documentation centre in the Sportimonium. Another key safeguarding strategy is promoting awareness among players about the cultural significance of their intangible cultural heritage. Special attention is devoted to attracting new members, especially young people and women. The model of Sportimonium can be applied elsewhere. One advantage of the programme is its modular design, divided into different phases that can be implemented according to local, regional, national and international contexts.

The Committee selects the Programme of cultivating ludodiversity: safeguarding traditional games in Flanders as a programme, project or activity best reflecting the principles and objectives of the Convention;

Congratulates the responsible organizations for this exemplary way of adapting intangible cultural heritage to contemporary settings;

Encourages those involved to make greater efforts towards sharing knowledge and national and international cooperation during the dissemination of best practices.



Skiing is one of the oldest modes of transportation known, predating the wheel with dated artifacts to prove its pedigree. Skiing for sport, however, did not become common until about 150 years ago. The first Winter Olympic Games, held in Chamonix, France in 1924, were the first to introduce skiing as a competition. Events were held in both ski jumping and cross-country skiing. With advances in technology and increased leisure time, the popularity of skiing as a sport has risen exponentially since it was first introduced.

The Historical Dictionary of Skiing relates the history of the sport through a comprehensive alphabetical dictionary with detailed, cross-referenced entries on key figures, places, competitions, and governing bodies within the sport. Author E. John B. Allen introduces the reader to the history of skiing through a detailed chronology, an introductory essay, appendixes and an extensive bibliography. This book is an excellent access point for researchers, students, and anyone interested in the history of skiing.
